OFFICE ORDER NO. 114 /Pers-II, Date: 25.02.2017.

The finding of the Central Selection Board held on 02.12.2015 in respect of Havildar Major Narendra Das (S.C.) of OSAP 6th Battalion, Cuttack (CSB Sl. No.10) for promotion to the rank of Deputy Subedars was kept in individual sealed cover due to pendency of OSAP 3rd Battalion, Koraput Proceeding No.03/14 against him. The said Proceeding was disposed off vide OSAP 3rd Bn., Koraput B.O. No. 2493 dtd.30.10.2015 and he was exonerated from charges. As per G.A. Department Office memorandum No.3928/Gen dtd.18.02.1994, the sealed cover containing finding of the CSB-2015 regarding his promotion has been opened.

Having been selected by the CSB-2015 Havildar Major Narendra Das (S.C.) of OSAP 6th Battalion, Cuttack is allowed promotion to the rank of Deputy Subedar with retrospective effect i.e. from the date of his junior Sri Harihara Sethi was promoted to the rank of Deputy Subedar as per the result of the CSB held on 02.12.2015. Accordingly, the inter-seniority of Sri Narendra Das is fixed in the rank of Dy. Subedar above Sri Harihara Sethi who was allowed promotion to the rank of Dy. Subedar vide Office Order No.130/ Pers-II, dt.08.02.2016.

His pay in the rank of Deputy Subedar shall be fixed notionally from the date of joining of his immediate junior Sri Harihara Sethi in the rank of Deputy Subedar.

This has been approved by the D.G. & I.G. of Police, Odisha, Cuttack.
