It is a pleasure to welcome you as a Cadet Sergeant of Police at Biju Patnaik State Police Academy (BPSPA), Bhubaneswar/ Police Training Institute (PTI), Byree Dist- Jajpur on 02.01.2017. You are requested to follow the joining instructions given below.

Sl. No. 1 to 16 in the State Police Hdqrs. Office Order No. 1155 /Pers.I Dt.21.12.2016 will report at Biju Patnaik State Police Academy (BPSPA), Bhubaneswar and Sl. No. 17 to 32 of the above Office Order will report at Police Training Institute (PTI), Byree, Dist- Jajpur on the above date fixed for basic Sergeants' course of training.

Please report at Biju Patnaik State Police Academy (BPSPA), Bhubaneswar/ Police Training Institute (PTI), Byree on 02.01.2017 AM positively. After reporting at Biju Patnaik State Police Academy (BPSPA), Bhubaneswar/ Police Training Institute (PTI), Byree, Dist- Jajpur, your physical and medical fitness shall be checked by the Medical Officer, who will issue Medical Fitness Certificate before acceptance of joining.

Approved uniform will be supplied on joining at Biju Patnaik State Police Academy (BPSPA), Bhubaneswar/ Police Training Institute (PTI), Byree, Dist- Jajpur. However, please bring the following items along with you.

1. Two pairs of formal trousers.
2. Full shirt, half shirt (formal).
3. Full shoes (formal) with socks.
4. Sports shoes (white) & white socks.
5. Tie.

A box not exceeding the size of 3' X 2' X 1 ½ , Mosquito net/ blanket, bed holder etc. may also be brought for personal use.

Two pairs of P.T. Uniform (white T. Shirt and Track lower) will be made available at the Training Centre, on payment. Approximate cost may be of Rs.1,500/- (one thousand five hundred) only.

Books and reading materials:

Study materials and Law Books will be supplied on payment to the trainees on arrival at the Biju Patnaik State Police Academy (BPSPA), Bhubaneswar/ Police Training Institute (PTI), Byree, Dist- Jajpur. The cost of the study materials may come approximately to Rs.3000/- (Three thousand) only.

Deposit of Advances at the time of reporting:

Each trainee shall have to deposit Rs.9,500/- (Nine thousand five hundred) only in total towards (cost of books-Rs.3000/-, Messing advance-Rs.5,000/-, P.T. Uniform -Rs.1,500/-) with the Cashier of Biju Patnaik State Police Academy, Bhubaneswar/ Police Training Institute (PTI), Byree.

Laundry:

The laundry has been outsourced to a reputed firm for machine washing and steam ironing. The charges are Rs.200/- per month for washing 40 garments.


Medical Fitness Certificate.

On arrival, the trainee shall appear before the Medical Officer (M.O) of Biju Patnaik State Police Academy, Bhubaneswar (BPSPA)/ Police Training Institute (PTI), Byree, Dist- Jajpur and get themselves medically examined. The M.O will issue a certificate indicating the fitness to undergo the physical training.

Leave: During the period of training, no leave will ordinarily be granted to the trainees, except in urgency.

Please submit the supporting original documents in respect of your age, Caste/ category, educational qualifications, Ex. Serviceman certificate, Sports certificate issued by the competent authority to the Biju Patnaik State Police Academy, Bhubaneswar/ Police Training Institute (PTI) Byree for re-verification.
