Kindly report at Biju Patnaik State Police Academy (BPSPA), Bhubaneswar/ Police Training Institute (PTI), Byree, Jajpur on 02.01.2017 AM positively. After reporting at Biju Patnaik State Police Academy (BPSPA), Bhubaneswar/ Police Training Institute (PTI), Byree, Jajpur, your physical and medical fitness shall be checked by the Medical Officer, who will issue Medical Fitness Certificate before acceptance of joining.

Approved uniform will be supplied on joining at Biju Patnaik State Police Academy (BPSPA), Bhubaneswar/ Police Training Institute (PTI), Byree, Jajpur. However, please bring the following items alongwith you.

Medical Fitness Certificate.


