OFFICE ORDER NO. 117 /Pers. I Date: 28.02.2017

S.I. Purusottam Jena of Spl. Branch, Bhubaneswar was selected for promotion to the rank of Inspector of Police by the C.S.B. held at State Police Hdqrs. on 25.5.2016. But, the findings of the CSB regarding his promotion was kept in individual sealed cover due to pendency of Bhubaneswar Vig. P.S case No.37 / 2011 and Spl. Branch Prog. No. 1/ 2016 against him. Thereafter he submitted representation to allow him promotion which was rejected by the DGP and the same was communicated to the S.P., Spl. Branch, Odisha, Bhubaneswar vide this Hdqrs. letter No. 38087/Board dt. 28.9.16. Against this order, Sri Jena filed O.A. No. 2680/2016 in the Hon'ble OAT, Bhubaneswar with prayer for his promotion to the rank of Inspector of Police by opening sealed cover. The Hon'ble OAT vide their order No. 3 dt. 16.11.16 directed the respondents to open the sealed cover in respect of applicant for his promotion to the rank of Inspector of Police as per the CSB held on 25.5.16 and consider his promotion, if he is other wise found suitable for promotion from the date his juniors were promoted. It has also been clarified by the Hon'ble OAT that, promotion giving to the applicant shall only on adhoc basis subject to final outcome of the Vigilance case pending against him. Against this order of the Hon'ble OAT, Government were moved vide this Hdqrs. letter No. 2392/TS dt. 19.1.17 to accord permission to file writ petition in the Hon'ble High Court of Orissa. In reply, Government vide Home Deptt. letter No.7204/FSS&IE dt. 23.2.17 have requested to ensure that Order No.-3 dt. 16.11.16 of the Hon'ble Tribunal passed in the above O.A. is implemented immediately in accordance with law in order to avoid future legal complication. As per the above Government order as well as the order of the DGP on 28.2.17, the above sealed cover containing the findings of the CSB- 2016 (CSB SI. No. 116) for promotion of SI Purusottam Jena to the rank of Inspector of Police has been opened and he is found selected by the CSB, 2016 for promotion to the rank of Inspector of Police.


SI Purusottam Jena is allowed promotion to the rank of Inspector of Police in the pay band of Rs.9,300/- Rs. 34,800/- with grade pay of Rs.4,600/- per month with retrospective date i.e. his immediate junior was allowed promotion to the rank of Inspector of Police. This promotion is subject to the decision of Hon'ble High Court in W.P (C) No. 426/06.

On such promotion, his inter-se-seniority is fixed above S.I Sarbeswar Malla of CID, CB, Odisha, Cuttack who has been allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. O.O. No. 619/Exe dt. 26.5.2016.

The conditional promotion will take effect from the date of his assuming higher charge in the promotional post. He may be reverted to the substantive rank of S.I. of Police depending upon the further order / final decision of the Hon'ble High Court. An undertaking to this effect will be furnished by him prior to joining in the promotional post.

On such promotion, SI Purusottam Jena of Spl. Branch, Bhubaneswar is posted to Spl. Branch, Bhubaneswar as Inspector of Police.


