
The case of S.I. Susanta Kumar Parida of Baragarh district was placed before the Central Selection Board held at State Police Hdqrs. on 25.5.2016 for consideration of his promotion to the rank of Inspector of Police. He was selected for promotion to the rank of Inspr. of Police on the basis of 0.25 times of the estimated vacancies as per G.A.Deptt. Notification No.19084/Gen. dt 9.7.2003. However, during the intervening period i.e. from the date of selection and before allowing him promotion, a departmental proceeding vide Baragarh district proceeding No.9/16 was drawn up against him. Hence, the findings of the CSB regarding his promotion was treated as sealed cover in pursuance of G.A.Deptt. Office Memorandum No.3928/Gen. dt 18.2.94. In the meantime, Baragarh dist. proceeding No.9/16 has been disposed of and he has been exonerated from the charges vide Baragarh District Order No.2001 dt 13.12.2016.

As such, SI Susanta Kumar Parida who was selected by the CSB (CSB SI. No.236) for promotion is allowed promotion to the rank of Inspector of Police in the pay band of Rs.9,300/- - Rs. 34,800/- with grade pay of Rs.4,600/- per month with retrospective effect, from the date his immediate junior SI Rajendra Swain (CSB SI. No.237) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No.1110/Pers.I dt 30.11.16. This promotion is subject to the decision of Hon'ble High Court in W.P. (C) No.426/06. He may be reverted to the substantive rank of S.I. of Police depending upon the decision of Hon'ble High Court. An undertaking to this effect will be furnished by him prior to his joining in the promotional post.

His pay will be fixed notionally in the time scale of pay of Inspr. of Police from the date his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade/post.

His posting will be decided in the next Police Establishment Board in accordance with Home Department Notification No.18407/D&A dtd 6.4.2007 and No.11880(M) dt 15.4.15.


