Having been selected by the Central Selection Board held on 22.5.2017 and in pursuance of Government of Odisha, Home Department Notification No. 11400/D&A dt. 28.2.2009, the following Constables who have passed the written examination of Constables to undergo the ASI's course of training are allowed to Officiate as ASI of Police in the pay band of Rs. 5200-20,200/- and Grade pay of Rs. 2800/-, where they have been posted now. If they have been transferred to other Districts/Establishments in the meantime, the concerned Dist/Estt. may allow them to officiate as ASI in their Dists/Estts. They will assume the higher charge of Officiating ASI of Police from the date of their joining. They will undergo training shortly.

Pending passing the final training examination, they will not be entrusted with the duty to conduct any enquiry or investigation as per the provisions of the Cr. P.C. during the officiating period as officiating ASI of Police. On the basis of the results of the final examination, their inter-se-seniority will be determined according to their relative seniority in the feeder grade. Their seniority in the rank of ASI shall be reckoned from the date of passing the final examination in ASI's course of training. If they fail in the final examination, they will be allowed two chances to clear the failed subject(s). In the event of failure to clear the failed subject(s) in two successive attempts, he /she shall be reverted to the substantive rank i.e. the rank held immediately prior to his/her officiating as ASI. The annual increments shall not be allowed unless and until the aforesaid examination is passed by the officiating ASI.
