Their seniority will be counted in the rank of S.I. of Police from the date of their selection by the CSB and will be placed in the State Gradation List in order of position assigned to them by the CSB provided they pass in the final examination of DCSI's course of training at Police Training Institute, Byree, Jajpur successfully. Those who fail in the examination shall be given another chance in the next examination to clear it without having to undergo the training again. If they fail again, they shall be reverted to the rank of A.S.I. as per Rule-28(2) of Government in Home Department Resolution No.22543/D&A dtd 27.5.2006 regulating the Orissa Police Service (Conditions of Service and Method of Recruitment of Sub-Inspectors) Order, 2006". Their annual increment will be granted after being declared passed in the DCSI's course of training as per the above rule.
