The case of C/269, Subash Chandra Barik of Sambalpur district was taken into consideration by the Central Selection Board held on 22.5.2017 for promotion Officiate as ASI of Police and the findings of the CSB was kept in seal cover due to pendency of Sambalpur Town PS case No. 87/03 (SBP SR No.91/03). Subsequently, he was acquitted by JMFC, Sambalpur vide CID, CB letter No. 27085/CB, SR-P, dtd. 29.7.2017. Thereafter, seal cover was opened on 20.5.2017 and it is found that he has been selected by the above CSB.

In accordance with Govt. of Odisha, Home Deptt. Notification No. 11400/D&A, dtd.28.2.2009, C/269 Subash Ch. Barik of Sambalpur district is hereby allowed to Officiate as ASI of Police in Sambalpur district. The date of officiating in the rank of ASI of Police will be counted from the date he actually assumes the higher charge as Officiate ASI of Police.

Pending passing the final training examination, he will not be entrusted with the duty to conduct any enquiry or investigation as per the provisions of the Cr.P.C during the officiating period as officiating ASI of Police. On the basis of the result of the final examination, his inter-se-seniority will be determined according to the marks obtained in the final examination. His seniority in the rank of ASI shall be reckoned from the date of passing the final examination in ASI course of training. If he fails in the final examination, he will be allowed two more chances to clear the failed subjects. In the event of failure to clear the failed subjects in two successive attempts, he shall be reverted immediately to the substantive rank i.e. the rank held prior to his officiating as ASI of Police. The annual increments shall not be allowed unless and until the aforesaid examination is passed by him.


