The case of WC/572, Puspanjali Behera of UPD, Cuttack was taken into consideration by the Central Selection Board held on 22.9.2017 for promotion to Officiate as ASI of Police and the findings of the CSB was kept in sealed cover due to pendency of Dhenkanal Town PS case No. 93, dtd. 30.12.2010 (U/S 366-A/109 IPC). In this connection S.P., Dhenkanal vide R.M. No. 3317/E dt. 21.9.17 has intimated that the above case was taken charge of investigation by the CID, CB, Odisha, Cuttack vide CID P.S. case No. 26 dt.30.12.2010 and Final Form has been submitted vide CID PS Final Report No.36 dt.28.12.11 in sufficient evidence. Thereafter, the matter was placed before the DGP. As per orders of the DGP, the sealed cover was opened on 20.10.2017 and it is found that WC/572 Puspanjali Behera of UPD, Cuttack has been selected by the above CSB.

In accordance with Govt. of Odisha, Home Deptt. Notification No. 11400/D&A, dtd.28.2.2009, WC/572, Puspanjali Behera of UPD, Cuttack is hereby allowed to Officiate as ASI of Police in UPD, Cuttack. She will assume higher charge as Officiating ASI of Police from the date of her joining.

Pending passing the final training examination, she will not be entrusted with the duty to conduct any enquiry or investigation as per the provisions of the Cr.P.C during the officiating period as officiating ASI of Police. On the basis of the result of the final examination, her inter-se-seniority will be determined according to the marks obtained in the final examination. Her seniority in the rank of ASI shall be reckoned from the date of passing the final examination in ASI course of training. If she fails in the final examination, she will be allowed two more chances to clear the failed subjects. In the event of failure to clear the failed subjects in two successive attempts, she shall be reverted immediately to the substantive rank i.e. the rank held prior to her officiating as ASI of Police. The annual increments shall not be allowed unless and until the aforesaid examination is passed by her.

This issues with the approval of DGP.
