
As per the recommendation of the Selection Committee held on 20.09.2017, 280 Sepoys / Constables of different Battalions including S /702 Sylbestar Xess of OSAP 3rd Bn. Koraput (S.L No. 224) were posted to different Districts on redeployment vide State Police Hdqrs. Office Order No. 708 / Pers. II dt. 07.10.2017, in which Sri Xess had been posted to Kandhamal District. But Sri Xess had opted for his posting to Sundargarh / Rourkela / Jharsuguda / Sambalpur / Baragada in order of preference instead of Kandhamal District. Hence he submitted an application for his posting as Constable to the District he opted for. On consideration of his application, a Review Board of the Selection Committee was held on 21.10.2017 for reconsideration of the case of S /702 Sylbestar Xess of OSAP 3rd Bn. Koraput for his redeployment to Civil Police as District Constable for rehabilitation. As per the recommendation of the Review Board of the Selection Committee, State Police Hdqrs. Office Order No. 708 / Pers. II dt. 07.10.2017 is partially modified. On such modification, the following Sepoys of OSAP 3rd Bn. Koraput and 4th Bn. Rourkela are posted to the Districts as noted against each on redeployment for their appointment as Constable in terms of Rule-4 Home Department Notification No. 57063 / D&A dt. 23.12.2010, No. 49686 dt. 31.12.2013 and No. 955 dt. 07.01.2015. Their inter-se-seniority, pay protection and training shall be Governed by the Home Deptt. Notification No. 49686 dt. 31.12.2013.




