Creation of additional posts for creation of 8 more Sub-Groups and increase of training and reserve capabilities of the Special Operations Group (SOG).

Sir,

In continuation of Home Department Government Order No.33019 dated 21.08.2004, I am directed to convey the sanction of the Governor for creation of another 816 (eight hundred sixteen) posts as detailed below in the scale of pay noted against each with usual D.A. and Other Allowances as sanctioned by Government from time to time, exclusively to deal with the extremists, insurgents and terrorist activities in the State.

2. The 735 number of posts for SOG indicated against the Sl. No.1 to 6 of the above table will be entitled to draw the monthly "Risk Allowance" at a rate of 50% of their basic pay without any upper limit. This will be paid in addition to the entitlement of other service benefits prescribed in the other relevant Government orders, except that any kind of "Special Pay", known by whatever name, shall not be paid in addition to the "Risk Allowance". Thus the Special Pay of Rs.150/- per month or the 15% of basic pay payable to the Police Personnel deployed in Left Wing Extremist (LWE) affected areas in accordance with Finance Department Resolution No.Pen-64/2001-53885//F, dated 02.11.2000, will not be paid to these 735 members of SOG.

3. The Menial Staff shall, either be obtained on deployment of regular recruit from other police establishments or be appointed on consolidated monthly remuneration on contract basis as decided by the Director, Intelligence from time to time. Prior approval of Government shall be obtained for the terms and condition and the monthly remunerable to be payable to them.

4. The terms and conditions laid down in Para-3 to 7 and 9 to 12 of the earlier Government Order No.33019 dated 21.08.2004 shall be applicable to these posts also.

5. The charge is debitable to the grant under the Head "Demand No.1-2055-Police-Non-Plan-104-Special Police-1327-Special Police Organisation" (voted) in the BE for 2006-07.
