Having been selected by the Special Central Selection Board held on 22.9.2017 & in pursuance of Govt. of Odisha, Home Department Notification No.11400/D&A, dtd. 28.2.2009 and in pursuance of the Order No.7, dt.15.3.2017 passed by the Hon'ble High Court of Orissa in W.P.(C) No.11216/16 filed by Upendra Gochhayat and batch of cases, the following Constables who have passed the written examination of Constables to undergo the ASIs' course of training are allowed to officiate as ASI of Police, where they have been posted now. If, they have been transferred to other Dists./Estts., the concerned Dists./Estts. may allow them to Officiate as ASI of Police in their Dists./Estts.. They will assume higher charge of Officiating ASI of Police from the date of their joining. They will undergo training shortly.

Pending passing the final training examination, they will not be entrusted with the duty to conduct any enquiry or investigation as per the provisions of the Cr.P.C during the officiating period as Officiating ASI of Police. On the basis of the results of the final examination, their inter-se-seniority will be determined according to the marks obtained by them in the final examination. In case more than one candidate will secure equal marks, the names will be arranged according to their relative seniority in the feeder grade. Their seniority in the rank of ASI shall be reckoned from the date of passing the final examination in ASIs' course of training. If they fail in the final examination, they will be allowed two more chances to clear the failed subjects. In the event of failure to clear the failed subjects in two successive attempts, he/she shall be reverted to the substantive rank i.e. the rank held immediately prior to his/her officiating as ASI of Police. The annual increments shall not be allowed unless and until the aforesaid examination is passed by the Officiating ASIs' of Police.
