OFFICE ORDER

Sl. No.11 Sri Sunil Harichandan was appointed as Cadet Deputy Subedar of Police vide State Police Hdqrs. Office Order No.1156/Pers-II dated 21.12.2016 in pursuance of Odisha Staff Selection Commission Notification No.3966/OSSC dated 07.12.2016. He was directed to join in the training centre on 02.01.2017 A.M. positively. However, he could not join in the training centre due to his domestic problem.

Thereafter, he appeared in grievance in the State Police Hdqrs., Cuttack to join his post. After careful consideration of his representation, he is allowed to join as Cadet Dy. Subedar in the office of the Addl. D.G. of Police, SAP, Odisha, Bhubaneswar by 30.11.2017 positively. If he fails to join within the stipulated period, his appointment will stand cancelled automatically without any notice to him.

He cannot claim seniority with the candidates who have been appointed vide State Police Hdqrs. Office Order mentioned above. All other terms and conditions reflected in his appointment order issued earlier shall remain unchanged. His service will be governed as per G.A. Department Order No.15592/Gen dated 19.07.2017 communicated vide State Police Hdqrs. Office Order No.568/Pers-I dated 10.08.2017.

On such appointment, he will be attached to the Battalion as per the order of the Addl. D.G. of Police, SAP, Odisha, Bhubaneswar till the next batch of training of the Cadet Dy. Subedars commences.
