2. After careful consideration, Government has been pleased to enhance the quantum of existing Special Operational Incentive from 60% of Basic Pay (extended vide this Department's Resolution No. 33211/D&A dated 20-09-2016) to Rs. 15,500/- per month in favour of contractual Constables / Sepoys deployed in SOG for anti-Naxal operations.

Further, the nomenclature of the said Incentive is now revised to 'Special Operational Incentive'.

- 3. In line with afore-mentioned decision, Government has also been pleased to extend 'Special Operational Incentive' of Rs. 23,400/- per month in favour of contractual Sub-Inspectors / Sergeants / Deputy Subedars, appointed under Odisha Group 'B' posts (Contractual Appointment) Rules 2013 and deployed in SOG for anti-Naxal operations.
- 4. The afore-said Special Operational Incentive is admissible only for the period for which they are posted in field during their deployment in SOG for anti-naxal operations.
