#### RESOLUTION

No <u>16062</u> /PW., Bhubaneswar, dated the <u>28-3</u> 2011. IPW-1/2011

Sub: Cash Reward to the personnel of Armed Wing of State Police.

The scheme of annual cash reward at Battalion and State Level for rendering meritorious services for O.S.A.P. personnel was laid down in Home Department Resolution No.22432/PW dt.14.05.2003 combinedly for the rank of Havildar Major, Deputy Subedar and Subedar to give one award.

2. The O.S.A.P. personnel are an integral part of Orissa Police. They play an equally important role in maintenance of law and order and Anti Extremist duties like Civil Wing Police personnel. In the meantime, more number of India Reserve Battalion, O.S.A.P. (Special Security) Battalion and Special Security Battalion of the Commissionerate have been raised and the Police personnel of these new Battalions are also entitled for such cash reward.

After careful consideration, the Government in supersession of the previous order vide Home Department Resolution No.22432/PW dt.14.05.2003 have been pleased to decide that annual cash rewards shall be given to all the six subordinate ranks of O.S.A.P. /India Reserve Battalion/ O.S.A.P. (Special Security) and Special Security Battalion of the Commissionerate in the following manner.

## 3. Eligibility:

3.1. To be eligible for an award, the persons should have rendered in the respective ranks the services as specified bellows:

- 1 - 2 - 1 - 1 - 2 - 2 - 2

- i) Sepoy 3 Years
- ii) LNK/Havildar- 2 Years
- iii) Havildar Major- 1 Year
- iv) Deputy Subedar- 2 Years
- v) Subedar- 2 Years

**3.2.** A person shall not be eligible for the award in a rank, if he has already got it earlier in that rank.

# 4. Criteria for Selection:

The selection shall be made on the degree of display of following attributes over the period of one year apart from outstanding work done in the discharge of his duties and responsibilities.

- i) Smartness in turnout in parade and ceremony.
- ii) Discipline and dedication.
- iii) Loyalty and obedience.
- iv) Integrity and honesty.
- v) Appreciation by subordinates and superiors of his control and supervision (for Havildar Major /Deputy Subedar/Subedar).
- vi) Remarks in CCRs (for Havildar Major /Deputy Subedar/Subedar).
- vii) Exemplary work done during law and order situation and anti extremist operations.

- 5. Selection Committee:
- 5.!. The Selection Committee for Battalion level cash award shall consist of following persons.

i) Range DIG of Police -Chairman

- ii) Commandant or in-charge Commandant of the Battalion- Member
- iii) Another Officer not below the rank of Deputy Commandant to be nominated by DG & IG of Police.
- 5.2. The Selection Committee for State Level Cash Award shall consist of the following persons.
- i) Additional Director General of Police, SAP-Chairman Or I.G. of Police, SAP (in absence of A.D.G.P., SAP)
- ii) Deputy Inspector General of Police –Member.( to be nominated by DGP)
- iii) One Commandant or In-charge Commandantof a Battalion by rotation to be nominated by DGP- Member
- 6. The decisions of the Selection Committee shall be final and binding.

7. This Scheme shall be effective from the calendar year 2011.

8. Where person selected for an award is subsequently suspended or is proceeded against for any misconduct before getting the award, he would automatically be debarred from receipt of such award.

9. The Director General and Inspector General of Police, who will be in overall charge of implementation of scheme of awards may issue supplementary instructions as and when required to facilitate smooth and orderly implementation of the scheme.

10. Any doubt in respect of interpretation of any provision contained in this Resolution may be referred to the Home Department for clarification.

11. This has the concurrence of Finance Department vide their UOR No.135/GSI dated 03.03.2011.
