

Sub:- Award of DGP's Disc to Police Personnel.

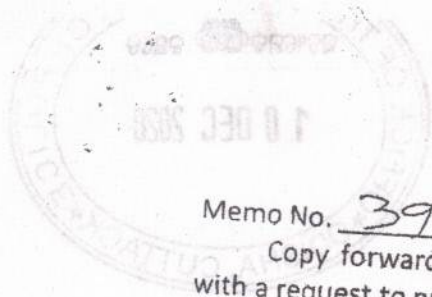
The question of enhancement of DGP's Disc to the Police Personnel of different ranks, who have rendered exceptional and meritorious service, was under consideration of the Government. After careful consideration, Government have been pleased to lift the cap on the number of DGP's Disc to be awarded to Meritorious Police personnel every year and to allow the same to be awarded anytime during the year.

1. The DGP's Disc shall be awarded Irrespective of the cash or other awards/rewards given to a person in the same year.
2. The decision to award the DGP's Discs will be taken by the Director General & Inspector General of Police, Odisha as and when the exceptional and meritorious service rendered by any police personnel comes to his notice. Details of such meritorious service shall be reduced to writing and certified by a police officer, who has direct knowledge of the service rendered by the concerned Police officer/man recommended for the award. Such certificate shall also be countersigned by a superior Police Officer.
3. However, if anything adverse comes to notice of the Director General & Inspector General of Police subsequently against the person decided to be awarded the DGP's Disc, the D.G. & I.G. of Police may cancel the decision of the award of the Disc.
4. The DGP's Disc to be awarded shall be made of German silver and will conform to the sample recommended by the State Police Headquarters in their Letter No. 30899 Dt. 26.6.96.
5. This resolution will come into force with immediate effect and the Resolution No. 13234/SAPW, dt.18.03.2020 on the award of the DGP's Discs to police personnel is hereby repealed.
