In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in partial modification of this Department Notification No.10577/D&A dated 25.02.2009 on the subject, the State Government do hereby redefine territorial jurisdiction of **Arjyapali Marine Police Station** under Chatrapur Revenue Sub-Division of Ganjam district under Coastal Security Scheme of Ministry of Home Affairs, Government of India, which shall have jurisdiction over the territorial waters in Bay of Bengal extending up to 12 Nautical Miles from the coast line between Haripur Bandar under Chamakhandi Police Station and Prayagi under Rambha Police Station and direct that Bada Arjyapalli Gram Panchayat and Gopalpur Port shall be under the jurisdiction of Aryapalli Marine Police Station on the date of publication of this notification in the Odisha Gazette.
