HOME-DAI-MISC-0064-2014/ 18572 / D&A. In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in partial modification of this Department Notification No.10553/D&A dated 25.02.2009 and notification relating to Bhograi Police Station, the State Government do hereby declare establishment of a Marine Police Station at Udayapur in Sadar Sub-Division of Balasore District to be called as **Talsari Marine Police Station** under Coastal Security Scheme, Phase - II of Ministry of Home Affairs, Government of India, which shall have jurisdiction over the territorial waters in Bay of Bengal extending up to 12 Nautical Miles from the coast line between 86 67'E, 21 21'N at Chaumukh under Baliapal Police Station and 87 29'E, 21 34'N under Udaypur Mouza with the territorial land comprising hamlets and revenue village as mentioned in the Schedule below and direct that the villages/hamlets which were hitherto included in Bhograi Police Station shall cease to have so included in Bhograi Police Station on the date of publication of this notification in the Odisha Gazette.
