## NOTIFICATION

No.HOME-DAF-MISC-0024-2014/ 18889 / D&A. In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in partial modification of this Department Notification No.10565/D&A dated 25.02.2009 and notification relating to territorial jurisdiction of Mohakalpara Police Station, the State Government do hereby declare establishment of a Marine Police Station at Tantiapal in Kendrapara Sub-Division of Kendrapara District to be called as **Tantiapal Marine Police Station** under Coastal Security Scheme, Phase - II approved by the Ministry of Home Affairs, Government of India, which shall have jurisdiction over the territorial waters in Bay of Bengal extending up to 12 Nautical Miles from the coast line between border point of Banapada village of Gogua Gram Panchayat in south and Chakulidiha village of Suniti Gram Panchayat in north of Mohakalpara Block with the territorial land comprising hamlets and revenue villages as mentioned in the Schedule below and direct that the villages/hamlets which were hitherto included in Mohakalpara Police Station shall cease to have so included in the said Police Station on the date of publication of this notification in the Odisha Gazette.


