powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in supersession of this Department Notification No.10559/D&A dated 25.02.2009 and partial modification of notification relating to jurisdiction of Basudevpur Police Station, the State Government do hereby declare establishment of a Marine Police Station at Chudamani in Bhadrak District to be called as **Chudamani Marine Police Station** under Coastal Security Scheme, Phase - II of Ministry of Home Affairs, Government of India, which shall have jurisdiction over the territorial waters in Bay of Bengal extending up to 12 Nautical Miles from the coast line between $21^{\circ} 08' N$ and $86^{\circ} 49' E$ at village Mohanpur Adia and $21^{\circ} 04' N$ and $86^{\circ} 50' E$ at Radhakantapur under Basudevpur Police Station along the coastline including Chudamani Fishing Harbour with the territorial land comprising hamlets and revenue villages as mentioned in the Schedule below and direct that the villages/hamlets which were hitherto included in Basudevpur Police Station shall cease to have so included in the said Police Station on the date of publication of this notification in the Odisha Gazette.
