No.HOME-DA1-MISC-0072-2014/ 27099 / D&A. In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in supersession of this Department Notification No.10559/D&A dated 25.02.2009 and partial modification of notification relating to jurisdiction of Naikanidihi Police Station, the State Government do hereby declare establishment of a Marine Police Station at Kasia in Bhadrak District to be called as **Kasia Marine Police Station** under Coastal Security Scheme, Phase - II of Ministry of Home Affairs, Government of India, which shall have jurisdiction over the territorial waters in Bay of Bengal extending up to 12 Nautical Miles from the coast line between 20° 55'N and 86° 55'E at village Nandapatna under Naikanidihi Police Station and 21° 04' N and 86° 50' E; at village Radhakantapur under Basudevpur Police Station along the coastline including Kasia Fishing Harbour with the territorial land comprising hamlets and revenue villages as mentioned in the Schedule below and direct that the villages/hamlets which were hitherto included in Naikanidihi Police Station shall cease to have so included in the said Police Station on the date of publication of this notification in the Odisha Gazette.
