But they shall be instantly available to Special Relief Commissioner in full strength as an ODRAF Unit for deployment any where in the State.
- When not deployed in disaster rescue work, the Unit may be engaged for police duty as decided by the S. P., Balasore but without adversely affecting its utility and deploybility as an ODRAF Unit.
- The charge is debitable to the grant under the head "Demand No.1 -2055 -Police - Non-plan- 109 - District Police - 0003050 - District Organisation" (voted) in the Budget Estimate for 2004-2005.
