

Sub: Revision of Washing Allowance in favour of all regular Group-D employees of the State Government

In pursuance of O.M. No.24779 of this Department dated 26.07.2013, all the regular Group-D employees of the State Government have been allowed Washing Allowance @Rs.100/- per month. The demands regarding revision of the Washing Allowance has been under consideration of the Government for some time past. Government after careful consideration have been pleased to revise the existing rate of Washing Allowance for all the regular Group-D employees of the State Government to a flat rate of Rs.200/- (Rupees two hundred only) per month.

The drawal of the Washing Allowance will be subject to the satisfaction of the Head of the Office that the concerned Group-D employee actually puts on the liveries.

This shall take effect from the next month of the date of issue.
