

## ODISHA POLICE STATE HEADQUARTERS CUTTACK.

OFFICE ORDER NO. 856/Pers. II.,

DT. 30 -07-2021.

State Govt. vide Home Department Order No.34053/D&A, Dtd.16.10.2020 have relaxed the provisions of Odisha Police Service (Method of Recruitment and Conditions of Service of Constables) Order, 2010 allowing filling up of 100% vacancies by redeployment instead of 20%, and the eligibility criteria for redeployment has been relaxed from 15 years of Service to 02 years. Further, the minimum age for redeployment has been relaxed from 40 years to 23 years in respect of Sepoys of OSAP 1<sup>st</sup> SS Bn., Sambalpur & OSAP 2<sup>nd</sup> SS Bn., Keonjhar as a onetime measure. Subsequently Govt. at Noting-13 of S.P. Hdqrs. OSWAS File No. DP-RERII-REDEP-0002-2021 allowed for redeployment of 149 Adhoc Sepoys of OSAP 1st SS Bn., Sambalpur & OSAP 2<sup>nd</sup> SS Bn., Keonjhar for their redeployment to District/ Estts. as Constable without insisting for two years of residency period as decided earlier vide Home department order No.34053/D&A, Dtd.16.10.2020. Further, Govt. vide Home Department order No.23751/D&A, Dtd.08.07.2021 have relaxed the provision for redeployment of remaining Sepoys of OSAP 1st SS Bn., Sambalpur from 40 years to 22 years instead of 23 years as relaxed earlier in Rule-4 of Odisha Police Service (Method of Recruitment and Conditions of Service of Constables) Order, 2010 vide letter No.34053/D&A, Dtd.16.10.2020 for their redeployment to Districts/ Estts. as Constable against the vacancies in the rank of Constable for the year-2020.

Accordingly, the Selection Committee held on 29.07.2021 for selection of remaining 38 Sepoys of OSAP 1<sup>st</sup> SS Bn., Sambalpur for redeployment as Constable in different Districts/Establishments for their rehabilitation, have selected the following Sepoys of OSAP 1<sup>st</sup> SS Bn., Sambalpur suitable for redeployment to the district Police for their appointment as Constable against the remaining vacancies of 2020 in terms of Rule-4 of Home Department Notification No.57063/D&A, dt.23.12.2010, No.49686, dt.31.12.2013 and No.955, dtd.07.01.2015. On redeployment, the above Sepoys are posted to the districts/ Estts. as noted against each. Their inter-se-seniority, pay protection and training shall be Governed by the Home Department Notification No. 49686, dt.31.12.2013.
