OFFICE ORDER No. 1369 /Pers-I, Dated 31,08.2023

The case of S.I. Saroj Kumar Mallick (CSB Sl.No.226 of 2013) of Koraput district was placed before the CSB-2013 held at State Police Hdqrs. , Cuttack on 8.3.2013 for consideration of his promotion to the rank of Inspector of Police but the findings of the CSB regarding his promotion was kept in individual sealed cover due to pendency of Rourkela district Proceeding No. 2/2009 against him. After conclusion of the proceeding , he was awarded 2 Black Marks in the above proceeding and the suspension period w.e.f. 27.05.2009 AM to 22.10.2009 AM (Total 148 days) was treated as "Such" vide Rourkela D.O.No.1337 dtd 17.04.2017. Then he filed an appeal petition before DIG of Police, WR, Rourkela against the order of punishment passed by SP, Rourkela which was rejected on 19.08.2017. Thereafter, he submitted a revision petition before DGP, Odisha which was also rejected on 31.07.2018.

S.I. Saroj Kumar Mallick filed O.A.No.2283/2018 challenging the orders passed by the Disciplinary Authority dtd 17.04.2017 and rejection order dtd 16.08.2017 of the Appellate Authority, D.I.G. of Police, WR, and order of Revisional Authority, DGP, Odisha dtd 31.07.2018. The above case was transferred to the Hon'ble High Court for adjudication after rescinding of the OAT. The Hon'ble High Court of Orissa passed its judgement in WPC (OA No.2283 /2018 vide its order dtd 28.07.2022. Later, the Govt. in Home Deptt. have been pleased to direct to implement the judgement dtd 28.07.2022 of the Hon'ble High Court of Orissa which has been concurred by the Law Department and Finance Department. Keeping in view of the order of the Hon'ble High Court dtd 28.07.2022 and as per orders of the Govt.in Home Deptt., the DGP, Odisha, Cuttack has been pleased to set aside the punishment of two Black Marks awarded to S.I. Mallick and treated the suspension period from 27.05.2009 to 22.10.2009(148 days) as duty vide State Police Hdqrs. Memo No.26419/Appeal dtd 18.05.2023.

Thereafter, he has submitted a representation to DGP for retrospective promotion from the year 2013 from the date of his juniors have been promoted to the rank of Inspector of Police.

The matter was examined at Board Section and placed before the DGP. As per orders of the DGP, the sealed cover containing the findings of the CSB for the year 2013 in respect of S.I. Saroj Kumar Mallick of Koraput district was opened on 23.08.2023 and found that he has been selected by the CSB for the year 2013 held on 08.03.2013.

SI Saroj Kumar Mallick is allowed promotion to the rank of Inspector of Police retrospectively from the year 2013 with effect from the date his immediate junior Ex. S.I. Sahadev Mohapatra (CSB SI. No.227 of 2021) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 513/Exe dtd 8.5.2013. Accordingly his seniority in the rank of Inspector of Police is fixed above Ex.S.I. Sahadev Mohapatra.

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade / post.

His promotional posting will be decided by the Police Establishment Board.

This issues with the approval of DGP.
