Cadet Sub-Inspector of Police (Armed) Jagannath Barad who was previously selected vide OSSC Notification No.3261/OSSC, Dtd.01-11-2021 had not reported for training in 2021 along with the 1st Batch CSI (Armed) of BPSPA, BBSR, as was required of him. He had submitted a representation for deferment of his joining on medical ground. On consideration of his representation, he was instructed to report at BPSPA, BBSR on 28-12-2022 to undergo Basic Course of Training of Sub-Inspector (Armed) along with 2nd Batch CSI (Armed) vide S.P. Hdqrs. letter No.53028/Pers.-II, dtd.22.12.2022. Sri Jagannath Barad, Cadet Sub-Inspector of Police (Armed) is declared to have "**Passed"** in the final examination of Sub-Inspector of Police (Armed) Basic Course of Training conducted at Biju Patnaik State Police Academy, Bhubaneswar.
