OFFICE ORDER NO. 988 /PERS-II, DATED. 29.11.2022

The case of Fitter Sub-Inspector Niranjan Mallick (Gen.) of PMT Establishment, Cuttack (CSB Sl. No.03) was taken into consideration by the CSB for the year 2021 held on 28.06.2021 for promotion to the rank of Fitter Inspector in PMT Establishment, but the findings of the CSB in respect of Fitter Sub-Inspector Niranjan Mallick (Gen) regarding his promotion to the rank of Fitter Inspector in PMT Establishment was kept in individual sealed cover due to pendency of PMT proceeding No.04/2020 against him. After conclusion of the above proceeding, he has been exonerated from the charges by the IGP (Commn.) vide PMT D.O. No.360, Dtd.05.08.2022.

Thereafter, Sri Mallick has submitted a representation praying for consideration of his retrospective promotion to the rank of Fitter Inspector from the year-2021. As per the orders of DGP the sealed cover containing the findings of the CSB for the year-2021 in respect of Fitter Sub-Inspector Niranjan Mallick (Gen) of PMT Establishment, Cuttack was opened on 10.11.2022 and found that he has been selected by the CSB for the year 2021 held on 28.06.2021 for promotion to the rank of Fitter Inspector.


Having been selected by the Central Selection Board-2021 held on 28.06.2021, Fitter Sub-Inspector Niranjan Mallick (Gen.) of PMT Establishment, Cuttack (CSB Sl. No.03) is allowed retrospective promotion to the rank of Fitter Inspector notionally with effect from the date i.e. 16.07.2021 his immediate junior Sri Singray Majhi, Ex. Fitter S.I. (Sl. No. 04) was allowed promotion to the rank of Fitter Inspector vide State Police Hdqrs. O.O. No.812/Pers.-II, dtd.16.07.2021. Accordingly, his seniority on retrospective promotion in the rank of Fitter Inspector is fixed above Sri Singray Majhi, Fitter Inspector.

Since there is no vacancy in the rank of Fitter Inspector in PMT Establishment to accommodate Sri Niranjan Mallick, as Fitter Inspector on promotion, the junior most Fitter Inspector, Himanshu Sekhar Rout (UR) (CSB Sl. No.09) who was promoted earlier to said rank vide S.P. Hdqrs. O.O. No. 812/Pers.-II, dtd.16.07.2021 being selected by the CSB-2021 held on 28.06.2021 shall be reverted to the rank of Fitter SI as per Para-6 of GA department Office Memorandum No.29699-SC-3-5/97-Gen., Dtd.01.11.1997.

His pay will be fixed notionally in the time scale of pay of Fitter Inspector i.e. Rs.9,300-34,800/- + Grade Pay Rs.4,200/- Cell-1 of Level-9 of pay matrix under ORSP Rule-2017 from the date his junior was allowed promotion to the rank of Fitter Inspector. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade/post.


