The case of Havildar Gagan Bihari Dehury (CSB Sl.No.51 of 2021) of Sambalpur district was placed before the CSB-2020 held on 24.08.2020 for consideration of his promotion to the rank of Havildar Major but the CSB after duly scrutinizing his service record decided to keep their recommendation in a sealed cover in pursuance of G.A.Deptt. O.M.No.3928/Gen dtdd 18.02.1994 as Deogarh district Town PS case No.03/2018 and Sambalpur district Prog. No.24/2018 were pending against him.

Havildar Sri Dehury has submitted a representation for consideration of his retrospective promotion to the rank of Havildar Major from the year 2020 as he was acquitted from the charges leveled against him in Deogarh Dist. Town PS case No.03/2018 by the Hon'ble Court of JMFC, Deogarh vide order dtd 05.09.2022. On consideration of the revision petition, the DGP has set aside the major punishment (One Black Mark) which was imposed to him in Sambapur Dist. Prog. No. 24/2018 vide Order dtd 14.03.2023.

As per orders of the DGP, the sealed cover containing recommendation of the CSB in respect of Havildar Gagan Bihari Dehury of Sambalpur district opened on 23.05.2023 and found that he has been selected by the CSB for the year 2020 held on 24.08.2020.

Having been selected by the CSB held on 24.08.2020, Havildar Gagan Bihari Dehury is allowed promotion to the rank of Havildar Major retrospectively with effect from the date of his junior was allowed promotion to the rank of Havildar Major vide State Police Hdqrs. office Order No. 670/Pers.I dtd 24.09.2020. His pay shall be fixed notionally. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade post.

On such promotion, he is posted to Sambalpur district against the vacant of ASI of Police in view of his retirement on 30.06.2023.
