They are liable to be discharged at any stage of their training career if their progress in monthly or periodical examination is found unsatisfactory or they otherwise render themselves undesirable.

They should be fit to attend parade and physical lessons throughout the year. Any report from a Doctor declaring any of the appointees unfit to undergo lessons for any length of time will make him/her liable for discharge from service.

Their inter-se-seniority in the rank of S.I of Police will be determined as per Home Deptt. Resolution No. 22706/D&A dt. 18.5.2010 & Home Deptt. Resolution No.22543/D&A dtd 27.05.2006.

It is a pleasure to welcome you as a Cadet Sub-Inspector of Police at Police Training College, Angul on 01.03.2021. You are requested to follow the joining instructions given below.

1) Location of PTC, ANGUL

The Police Training College, Angul is situated at a distance of 1.5 KMs from Angul Bus Stand & 3 KMs from Angul Railway Station. Conveyance of PTC will be made available from the Bus Stand and Railway Station.

2) REPORTING

Please report at Police Training College, Angul on 01.03.2021 positively for Basic SI's course of training. After reporting, your physical and medical fitness shall be checked by the Medical Officer who will issue Medical Fitness Certificate before acceptance of joining.

- a) Trainees on arrival will report before the Reception Desks situated near Pabitra Mohan Preskhyalaya.
- b) Trainees will be allotted rooms in the hostel by the officer in-charge of the reception desks on first come first serve basis.

3) ACCOMMODATION & MESSING

The Police Training College has adequate arrangements of boarding/lodging of the trainees, Cadet Sub-Inspectors shall report to the concerned hostel Superintendents after allotment of seat at reception centre.

4) UNIFORM AND CLOTHING

Approved Uniform will be supplied on joining at Police Training College, Angul. However, please bring the following items alongwith you.

5) **BOOKS AND READING MATERIALS:**

Study materials and Law Books will be supplied on payment to the trainees as per availability and requirement of the trainees on arrival at PTC, Angul.

DEPOSIT OF ADVANCE AT THE TIME OF REPORTING:

Each trainee shall have to deposit Rs.8,000/- (Rupees Eight thousand) only towards advance messing charge Rs.5000/- (Rupees Five thousand) only, Safety Deposit (refundable) Rs.3000/- (Rupees Three thousand) only.

MEDICAL FITNESS CERTIFICATE:

On arrival, the trainee shall appear before the Medical Officer (M.O) of DHH Angul, where they will be medically examined. The M.O will issue a certificate indicating the fitness to undergo the training.

8) LEAVE:

During the period of training, no leave will ordinarily be granted to the trainees, except under medical emergency.
