OFFICE ORDER NO. 877 /PERS.-(II),

The case of Driver Havildar Major Biswanath Sahoo (Gen) of P.M.T. Cuttack (CSB Sl. No. 4) was taken into consideration by the CSB for the year 2022 held on 29.04.2022 to adjudge his suitability along with other eligible Driver Havildar Majors for promotion to the rank of M.T.S.I.. The Central Selection Board after scrutinizing his service records decided to keep their recommendation in individual sealed cover due to pendency of P.M.T. departmental proceeding No. 03/2020 against Driver Havildar Major Biswanath Sahoo in pursuance of Government of Odisha G.A. Department, Office Memorandum No. 3928/Gen.Dtd. 18.02.1994.


In the meanwhile, the above departmental proceeding has been disposed off by awarding him with a minor punishment i.e. "Censured in S.B." as intimated by S.P. PMT vide his letter No. 2055/PMT-RO Dtd. 11.07.2022. After disposal of the said proceeding with minor punishment, I.G. of Police Communication Odisha, Cuttack has requested to open sealed cover in respect of Driver Havildar Major Biswanath Sahoo (Gen) of PMT Hdqrs. Cuttack for consideration of his retrospective promotion to the rank of M.T.S.I. After thorough examination of records, DGP Odisha has been pleased to allow IGP Communication to open the sealed cover containing the findings of the CSB-2022 in respect of Driver Havildar Major Biswanath Sahoo of PMT Hdqrs. Cuttack for promotion to the rank of M.T.S.I.. Accordingly the sealed cover was opened on 08.09.2022 and it was found that, he was selected by the CSB-2022 held on 29.04.2022 for promotion to the rank of M.T.S.I.

Having been selected by the Central Selection Board-2022 held on 29.04.2022, Driver Havildar Major Biswanath Sahoo (Gen) of PMT, Cuttack is allowed promotion notionally to the rank of M.T.S.I. retrospectively from the date his immediate junior Ex-Driver Havildar Major P.A. Minz (ST) (CSB Sl. No.-5) who was allowed promotion to the rank of M.T.S.I. vide State Police Hdqrs. O.O. No. 397/Pers.-II, dtd.29.04.2022. His seniority is fixed above P.A. Minz, Ex- Driver Havildar Major.

His pay will be fixed notionally in the time scale of pay of M.T.S.I. from the date of his junior was allowed promotion to the rank of M.T.S.I.. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade/post.

This issues with the approval of the DGP.


