

ODISHA POLICE STATE HEADQUARTERS CUTTACK.

The finding of the Central Selection Board held on 7.1.2020 in respect of ASI (Communication) of Signals Establishment (CSB Sl.No.13) for promotion to the rank of SI (Communication) was kept in individual sealed cover in pursuance of Govt. of Odisha G.A. Department Office memorandum No.3928/Gen dtd.18.2.1994 and subsequent amendment to the provision in the above O.M. vide G.A. Deptt. O.M. No.29699/Gen dtd.1.11.1997 as Sambalpur district proceeding No.23/2018 was pending against him. As per orders of the DGP, Odisha, the Sambalpur district proceeding No.23/2018, which was initiated against Sri Panda has been dropped by S.P. Sambalpur vide Sambalpur district D.O. No.1040 dtd.4.11.2020.

As per orders of the DGP the sealed cover containing findings of the CSB in respect of ASI (Communication) Akshaya Kumar Panda of Signals establishment was opened on 5.5.2021 and it is found that he was selected by the CSB-2019 held on 7.1.2020 for promotion to the rank of SI (Communication).

But, he was allowed promotion to the rank of S.I. (Communication) vide S.P. Hdqrs. Office Order No.866/Pers-II dtd.29.12.2020 as per the results of the CSB-2020 held on 23.12.2020.

In view of the above, Sri Akshaya Kumar Panda S.I. (Communication) of Signals establishment is allowed retrospective promotion in the rank of S.I. (Communication) w.e.f. the date his immediate junior ASI (Communication) Sushil Nayak (ST) (Now S.I. Communication) (C.S.B. No.14) was promoted to the rank of SI (Communication) as per the results of the CSB held on 7.1.2020. The inter-se-seniority of Sri Akshaya Kumar Panda is fixed in the rank of SI (Communication) above Sri Sushil Nayak who was allowed promotion to the rank of SI (Communication) vide Office Order No.30/Pers-II dtd.8.1.2020.

His pay in the rank of SI (Communication) shall be fixed notionally from the date his immediate junior Sri Sushil Nayak was promoted to the rank of SI (Communication).
