POLICE ORDER No. 256

SUBJECT—Consignment of Finger Print slips necessity of.

The existing P. R. system is not working well as a result of which the flow of Finger Print slip to the Finger Print Bureau is enormously hampered.

The Jail Parade Registers and Final Memos. are not put up before the concerned S. Ps. for obtaining timely P. R. orders in appropriate cases, and consequently Finger Print slips are held up in Court Offices and not sent to the Bureau for consignment.

This situation provides an opportunity to the veteran and habitual criminals to escape surveillanes and the chances of being traced or identified on subsequent occasions. It therefore adversely affects the criminal administration and the Police is losing track of veteran criminals gradually. The whole purpose of Finger Print system is also lamentably defeated.

Preservation of Finger Print slips in the Bureau has manifold objectives. The P. R. system only provides an extra objective, that is to keep surveillance over the criminals. In the changed circumstance it is necessary to keep Finger Print slips in the Bureau for allied purposes no matter whether P. R. orders are passed or not.

The C.S. Is. are hereby directed to take Finger Prints of all the convicted persons soon after their conviction under the following Acts and consign them to the Finger Print Bureau under proper despatch checks.
