Recruitment of Odisha Revenue Service(ORS) (Group-B) by way of Selection for the recruitment year, 2020.

Sir,

I am directed to say that, it has been decided by the Government in Revenue & Disaster Management Department to recruit 03 nos. of Officers (UR-Nil, SC-Nil, ST-03) to the cadre of Odisha Revenue Service(ORS) (Group-B) by way of "Selection" for the recruitment year, 2020 under Rule-4(c) of the Odisha Revenue Service (Recruitment) Rules, 2011 and ORS(Recruitment) Amendment Rules, 2020 from among the officers having the following eligibility criteria with Outstanding merit and ability.

- a) He/ She is a graduate and has worked for at least 05 years of service in Group-C post carrying a scale of pay of Rs. 4,750-7,500/- in pre-revised scale of pay(ORSP Rules 1998) & Pay Band-2, Rs-9,300-34,800/- with Grade Pay of Rs. 4,200/- in pre-revised Scale of pay (ORSP Rules, 2008) Corresponding to pay at Level-9 as per Pay matrix under ORSP Rules,2017 or higher scale of pay as on 1st January, 2020.
- b) He/ She has passed Departmental Examination, if any.
- c) Not more than 50 years of age as on 1st January, 2020.

- For recommendation against Selection, you are requested to ensure that the names of the willing candidates who really deserve consideration on the basis of their outstanding performance and exceptional merit as reflected in their CCRs/PARs are to be sponsored to this office. An undertaking to accept the appointment on selection to ORS (Group-B) should be obtained from the concerned candidates.
- The recommending authorities are particularly requested to see that all columns
 of the prescribed proforma(enclosed) are correctly filled up separately in
 respect of each nominee with accurate particulars duly authenticated.
- 4. The recommending authorities are requested to furnish the attested copies of relevant pages of Service Books / Orders if any, in support of age, educational qualification, date of entry into Govt. Service with designation, date of pay fixed at pay scale of Rs. 4750-7500/- or higher(as per ORSP Rules 1998), date of pay fixed at pay band-2 Rs. 9,300-34,800/- with grade pay of Rs. 4,200/- or higher(as per ORSP Rules 2008), date of pay fixed at Level-9 or higher (as per pay matrix under ORSP Rules 2017), departmental examination of recommended eligible employees alongwith Service particulars & CCRs/PARs to Board of Revenue after thorough verification.
- 5. The recommending authorities are requested to furnish attested photocopy of latest available 05(Five) years CCRs/PARs preceding the Recruitment year, 2020(i.e. from 2014-15 to 2018-19) of officers who are eligible as on 1st day of January of the Recruitment year, 2020 as per Rule-3(C) of the Orissa Civil Service (Criteria for Promotion) Rules, 1992 read with clarification issued by Government in General Administration Department vide Letter No. 4280, dated 19.02.2010. The employees having minimum 3 years of CCRs among preceding years(from 2014-15 to 2018-19) may be recommended and in case of non-availability of CCRs/PARs of any of the said period, back CCRs/ PARs of the corresponding number of years may be furnished. No Remarks Certificate may be furnished for the non-available period of CCRs/ PARs. The recommendation should be routed through their respective Heads of Department/ Department of

Govt. as the case may be & reach the Board within the stipulated period. Any application received directly at Board of Revenue without the Knowledge of concerned Heads of Department/ Department of Govt. will be rejected out rightly & will not be considered at all.

- 6. The Ministerial Officers/ Revenue Field Service Staff working under Revenue Administration need not be recommended for Recruitment to ORS against "SELECTION" category for the year, 2020 as per Rule 4(C) of ORS(Recruitment) Rules, 2011 as they are coming under the category of recruitment to ORS cadre by way of promotion.
- No candidate should be recommended against whom CBI/ Vigilance/ Departmental or Judicial Proceeding is pending or being contemplated.
- While sending the recommendation to the Board of Revenue, Odisha, Cuttack, the recommending authorities are requested to arrange the names according to their seniority following the principle provided under Rule-8 of Odisha Revenue Service(Recruitment) Rules, 2011.

- 10.
